ATTENDANCE: 27

PROGRAM

John Oakberg, Winterizing Garden Tools.

CALL TO ORDER:

The business meeting was called to order by President Dixie Seaton at 7:05 PM.

SECRETARY REPORT

The minutes of the September 18, 2023, were approved by unanimous voice vote without change.

TREASURER'S REPORT

The Treasurer's Report for September was accepted by unanimous voice vote. John Oakberg reported that for the first time this year the UT and local accounts balanced perfectly. Dixie reminded the committee heads that their 2024 budget requests are due by November 1st.

COMMITTEE REPORTS

SPEAKER'S BUREAU: No activity.

JMGS: Melanie Hill reported that on October 4 the JMGs made a field trip to Sugarlands for a soil and water quality workshop. Also, in our greenhouse the JMGs will be planting native plants in January for the 2024 SCAMGA Plant Sale. **DEMO GARDEN:** Diane McCullen requested assistance with blowing out the irrigation lines; an air compressor is needed. She also stated that the pollinator garden will be expanded and room made for the planned medicinal herb garden.

GREENHOUSE: Karen Hall reported that this year we are attempting to get a head start on the plant sale by growing plants all during the winter months. She also stated that more potting soil is needed.

PLANT SALE: Dixie stated that a volunteer is needed to be the Plant Sale Chair for 2024. Karen Hall and Shauna Bayless volunteered to be co-chairs.

SENIOR CENTER: Glenna Julian reported that Matt Anderson will be presenting a program on succulents at the Senior Center on November 8 at 2 PM. Also, Christmas for the Birds workshop for making bird feeders from pine cones will be conducted on Wednesday, December 20th.

OTHER COMMITTEES: There were no new committee reports for the Tomato Seed Project or Wilderness Wildlife Week.

OLD BUSINESS

BY-LAWS: John Oakberg reported that he has completed revision of the SCAMGA By-Laws and satisfied the distribution and reporting requirements so that voting on them is now possible. Dixie called for a vote and the revised By-Laws were accepted by unanimous voice vote.

PROGRAMS: Diane McCullen reported that Donna Stinnett and Lois Cooper will present the November program. The topic is still to be determined.

into the woods with jmg

Learning about the environment that we live in is important, especially for those who will be the future caretakers of the Smokies. Junior Master Gardeners spent a day learning how to assess the quality of both streams and soil at the NPS Sugarlands visitor center. From trawling the streams for aquatic life to assess water quality to examining bugs in the soil, JMGers had an exciting learning experience.

Continuing our study of the Smoky Mountains, JMGers studied different ways to identify trees by looking at the leaves and bark of a sampling from the 100 native tree species that make this area their home. They also learned how to dry press leaves to use in making botanical art.



tool tips:

FOLLOW-UP TO THE OCTOBER PROGRAM ON KEEPING YOUR GARDEN TOOLS IN GOOD CONDITION

I really enjoyed the great questions and comments during the program at the October meeting. As always, there are more things that could be presented and maybe next year when machines are about to come out of hibernation, we could revisit the subject.

There are two topics I want to mention again about storing gaspowered machines and running them dry before putting them away for the winter: using gas additives and where not to run a gas engine.

If you use a gas additive, it is all right to let the gas remain in the engine tank over the winter, although running the tank dry is the preferred practice. If you do not use an additive, empty the gas tank and run the engine dry. If you leave gas in the tank (with additive), be sure to store the machine away from any heat source – treat it like you are storing a container full of gasoline – because you are!

As for running an engine dry, be sure to do it outdoors, well away from open windows or doors, and do not run a combustion engine inside a garage, even with the doors open. This applies to generators as well, which can see use anytime during the year.

I also remembered other places that have small engine repair shops: the Co-op and Blalock Hardware, although I am not sure if they service only what they sell. They both have been a good parts source for me, and will order if they do not have it in stock. Parts are also available online.

Regardless of the engine type (electric or gas) be sure to clean the tool and lubricate it before storage. Spray WD-40 or wipe a light coat of oil on the areas most prone to rust during storage, such as the underside of mower decks and on blades. If your gas engine is due for an oil change, wait until spring for that maintenance. For battery powered tools, be sure to read the manual about battery storage and charging (if needed or not) during the off season.

As more thoughts about tools come to mind, I'll try to write something up for future Newsletters. In the meantime, if you all have any questions, I will do my best to answer them – send me an e-mail or call.
